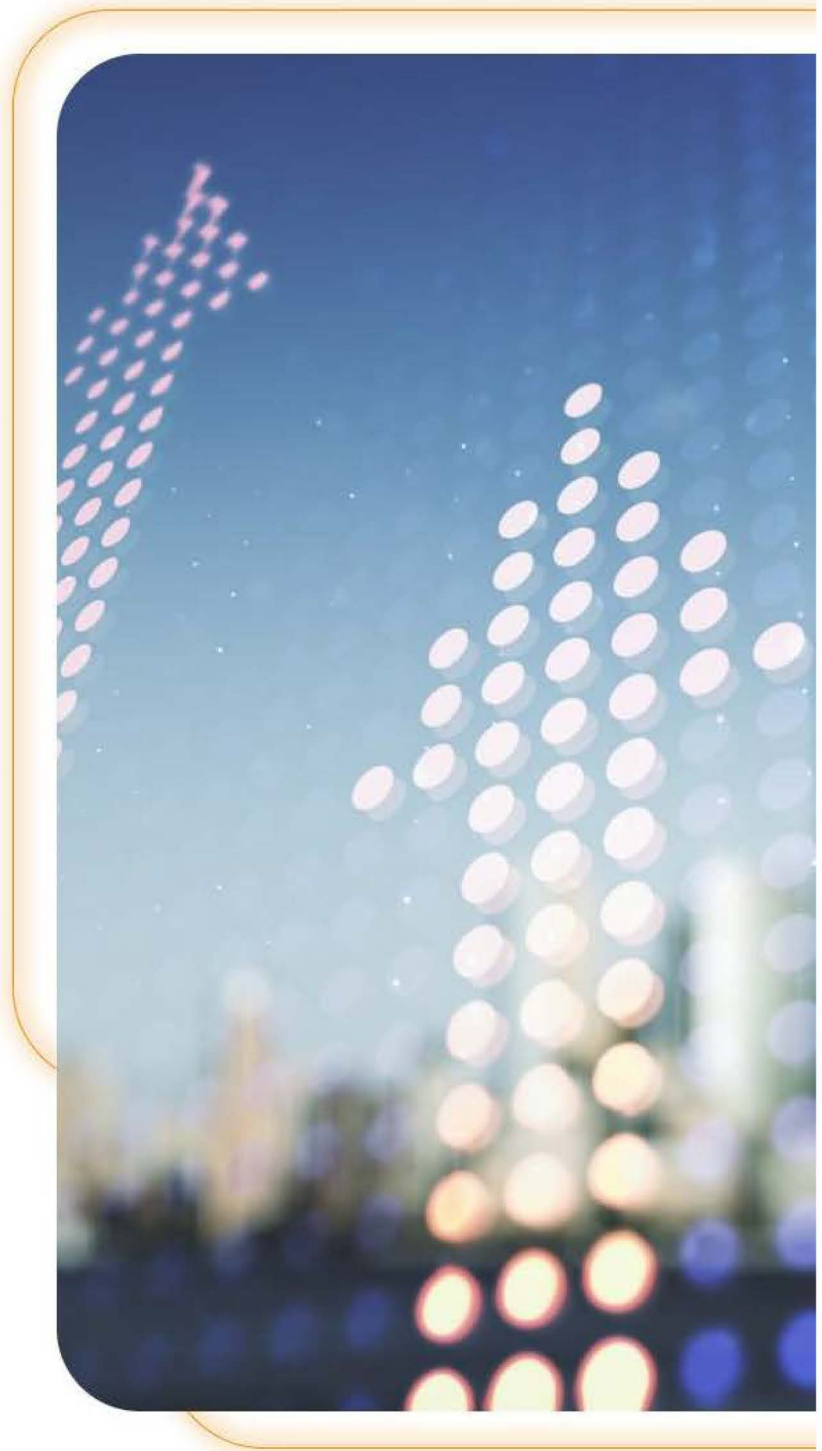

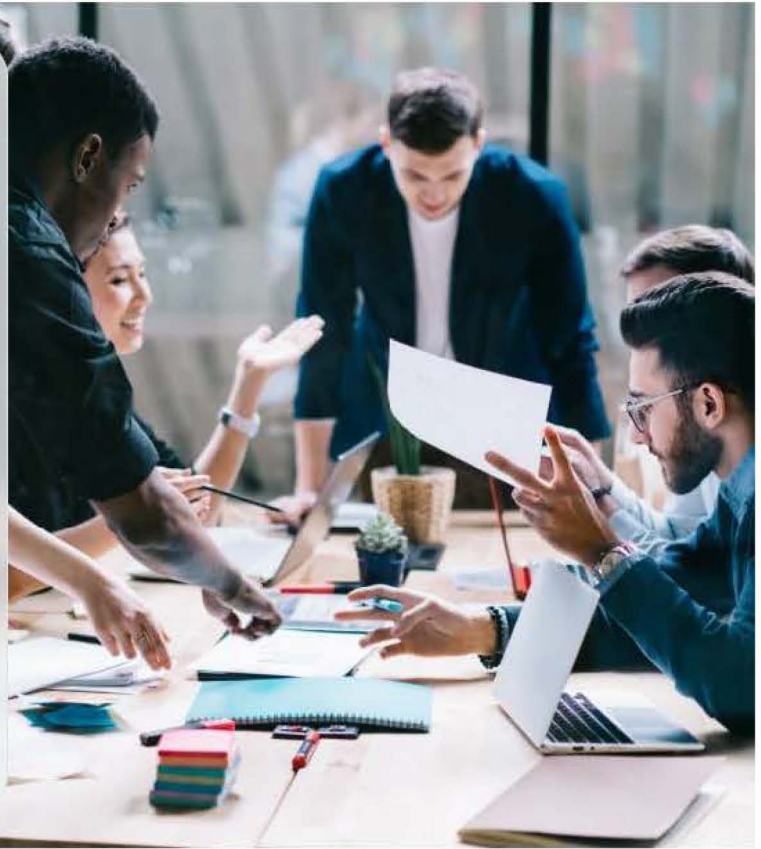

**81%** of companies lost Microsoft Office 365 data

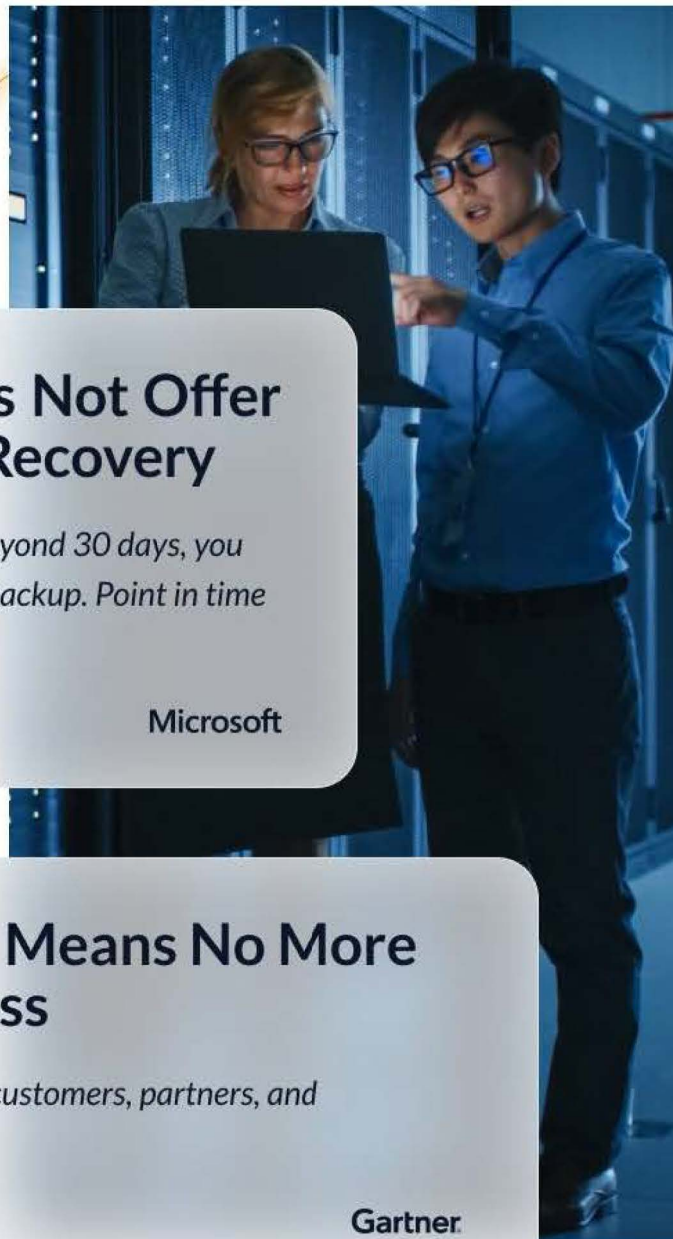

## Microsoft Does Not Offer Point-in-time Recovery

*If you want to support recovering messages beyond 30 days, you would need to use a 3rd party service for the backup. Point in time restoration of mailbox items is out of scope.*


