



Microsoft 365 bundles document creation, collaboration, and communication in a cloud-based subscription service. **SharePoint** is the default repository for Microsoft 365 content, with **OneDrive** and Microsoft **Teams** used for personal storage and small team collaboration and sharing. **Microsoft Purview** and Microsoft **Syntex** support data governance, including tools for managing retention schedules, legal holds, and sensitive data identification. Together, these capabilities offer basic content services for individuals and teams.


But is this enough to power modern work?

Challenges facing Microsoft 365 customers

Content sprawl

Multiple, overlapping sharing capabilities (OneDrive, Teams) lead to user disorientation, duplicate copies of documents and process improvisation. This inefficiency results in lost productivity, data leak risks and non-compliance. Left unchecked, content sprawl can create serious long-term cybersecurity and privacy compliance risks.

Content disconnected from process

While Microsoft 365 offers basic information classification and governance capabilities, these control mechanisms are disconnected from critical business processes and data. For companies operating in highly regulated industries or managing process-intensive tasks, complexity is the enemy. Content must be contextually integrated with business processes across the enterprise.

Complexity and loss of control

As a pervasive infrastructure service, Microsoft 365 demands careful configuration. Regulatory compliance requirements for content and key data can create management challenges for IT departments. Complexity can also lead to unforeseen cybersecurity vulnerabilities, as efforts to automate and govern information are often at odds with IT's desire to standardize and simplify Microsoft 365.



Business Workspaces offer fast access to pertinent information in a simpleto-digest view. Using pre-built templates, users can quickly organize content, data, people and tasks related to projects, cases or business activities. Business Workspaces free up IT resources to deliver business applications, connect content to enterprise applications and minimize point solutions.

Teams provisioning automatically generates Teams from each Business Workspace, integrating Teams collaboration within applications such as SAP, SuccessFactors, Dynamics 365 and Salesforce.

Teams synchronization allows Teams users to transparently collaborate on content within the "Files" tab, while OpenText provides secure and seamless governance oversight in the background.

Teams archiving keeps user collaboration safe and uncluttered at the conclusion of a project for long-term retention, recording chat history, attachments, files and other data within the Business Workspace.

Collaborative editing allows users to co-edit content in the Business Workspace without worrying about checking documents in and out, as legacy document management systems require.

Intelligent email filing for Microsoft Outlook helps users identify the right Business Workspace for long-term retention of important emails.

Microsoft Purview Information Protection encrypts sensitive content on the fly to provide strong enforcement of security clearances, protecting them against unauthorized viewing, copying or modification.

Microsoft Dynamics 365 integration connects content to business processes to streamline workflows, automatically creating metadata and delivering content to users directly within the Microsoft 365 Dynamics interface.

Power Automate integration points enable organizations to build custom workflows and process rules that allow seamless information flow between Business Workspaces and Microsoft applications.

Business Scenarios are pre-configured applications featuring the above capabilities. Designed to expedite deployment, these applications apply best practices for vertical processes in public sector, financial services, energy and life sciences or common scenarios such as cases, contracts, projects and SOPs.
